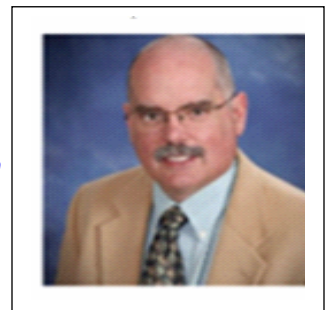

City Council Rules

#26 No member shall be considered present unless the member is within the Council Chamber.

#27 No member shall leave a Council meeting without permission from the Presiding Officer of the meeting. Once permission has been granted, and upon direction by the Presiding Officer, the City Clerk shall remove said member's name from Council's computerized record-keeping system.
